- Leveraging the badge of government to establish trusted relationships, you will build strategies for engagement and assist Taiwanese organisations to access investment opportunities across Queensland.
- Guide and support Taiwanese companies to pursue investment opportunities in Queensland including providing market intelligence, business leads, advice, introductions, vetting of partners and assessing opportunities
- Leverage migration programs including the Global Talent Visa and state sponsored Business Migration Visas to facilitate investment outcomes for Queensland.

- 5. Provides advice to stakeholders that is rigorously considered and supported by a clear rationale

# Eligibility

To be eligible for consideration and appointment, you must have:

- Work Authorisation to be eligible for employment within TIQ, you must be legally authorised to live and work within Taiwan and provide the required evidence to support your eligibility.
- **Language** the successful candidate must be a highly motivated team member, fluent in both written and spoken English. Fluency in Chinese language is also essential to success in this role.
- Security Clearance the successful candidate must be willing to undertake a screening check and be confirmed as a suitable person to access Government resources prior to commencing in the role.

# How to apply

- Appointments in TIQ are merit based and will be assessed by reviewing what you have done previously the knowledge, skills and experience you've built, your potential for development, and your personal qualities.
- TIQ will review the applications and advise you as to the next phase of assessment for this role, which could include an interview, work assessment, and/or other selection techniques.



- Referee checking will be undertaken, and other pre-employment checks may occur prior to any offer of employment. Checks may include (but are not limited to) proof of eligibility for appointment, a criminal history check and a serious discipline history disclosure check.

- LES employees are not Queensland public service officers. LES employees are engaged under local labour legislation, specific to the market outline under the "location" above and will be remunerated in accordance with the specified markets entitlements.
- Remuneration is paid through a local payroll service provider and subject to statutory obligations.
- Prospective applicants need to demonstrate that they are eligible to work in the nominated country for the duration of the appointment by legally meeting the local citizenship or visa requirements, which places no obligation on TIQ.
